Instructions:

For the fall and spring semesters, undergraduate students may enroll in a maximum of 16 units throughout the Early/Final Priority Period of registration. During Open Registration, a maximum of 19 units is allowed. All requests for 20 units or more must be approved by the Dean of the College in which your major is housed. Students should have a 3.0 cumulative grade point average. Course permit numbers must be obtained starting the first day of instruction.

To enroll in 20 units or more, students must:

1. Complete all sections of this petition and attach a current SF State (or other college) transcript.
2. Obtain approval from your major advisor, major department chair, and college dean that houses your major. Undeclared and Special Majors must obtain major advisor/chair approval from the Advising Center and dean approval from the Dean of Undergraduate Studies (ADM 447).
3. All approved petitions must be submitted to the Registrar's Office at the One Stop Student Service Center for final processing.
4. In addition to the approvals required in #2 above, students seeking to enroll in 25 units or more must obtain approval from the Dean of Undergraduate Studies (ADM 447) before the end of the fourth week of instruction.

Summer Semester:

During Summer Semester, undergraduate students have session unit limits and an overall Summer Semester limit of 14 units. To enroll in more units per session or semester, follow steps 1 through 3 listed above.

- R1: (5 weeks; maximum of 7 units)
- R2: (8 weeks; maximum of 9 units)
- R3: (5 weeks; maximum of 7 units)
- R4: (10 weeks; maximum of 12 units)

After processing, student may add via permit number on Gator Reg.
